

**RESOLUTION OF THE BOARD OF DIRECTORS
OF BRAINATION, INC.
CHARTER HOLDER OF INSPIRE ACADEMIES
REQUEST FOR CHARTER EXPANSION AMENDMENT
ADDITIONAL CAMPUS – SAN ANTONIO OPPORTUNITY SCHOOL**

WHEREAS, BRAINATION, Inc. is the governing body of the charter holder, and is the governing body of the open-enrollment charter school named Inspire Academies; and

WHEREAS, under 19 Texas Administrative Code §100.1033(a) the terms of an open-enrollment charter may be revised with consent of the charter holder by written amendment approved by the commissioner of education in writing; and

WHEREAS, as required under 19 Texas Administrative Code §100.1035(c)(5)(B)(i-xiii), the charter holder governing body has considered a business plan and has determined by majority vote of the board that the growth proposed is financially prudent relative to the financial and operational strength of the charter school; and

WHEREAS, as required under 19 Texas Administrative Code §100.1033(b)(10)(D), a charter holder seeking approval of a charter expansion amendment for a new campus is required to obtain formal authorization from its governing board approving the submission of the request to the Texas Education Agency; and

WHEREAS, the Board of Directors of BRAINATION, Inc. has reviewed the proposed charter expansion amendment for a new campus request, as well as the materials to be submitted to TEA in support of such request.

NOW, THEREFORE, the Board of Directors of BRAINATION, Inc. charter holder of Inspire Academies, at a lawfully called meeting with a quorum of the Board, held in compliance with the Texas Open Meetings Act, do hereby adopt the following resolution:

BE IT HEREBY RESOLVED THAT:

BRAINATION, Inc. charter holder of Inspire Academies apply to amend its open-enrollment charter to:

- expand to a new campus in San Antonio, Texas to serve grade levels 7-12 beginning August 2027 named San Antonio Opportunity School; and
- waive 19 Texas Administrative Code §100.1033(b)(9)(A)(iii), which states expansion amendment approval is conditional to “academically acceptable” district rating and 90% of the campuses are at least “academically acceptable” due to 50% of our campuses are residential facility schools rated as “Not Rated.”
